Dear Mr. Aloisio:

This letter is being written in response to Mr. Turner's letter of April 2, 2012 asking for comments or questions on the proposed zone change application for the Oak Tree Dairy property. The Elwood Board of Education discussed this matter at our open meetings on May 3, May 17, in which we entertained a presentation from the developers, The Engel Burman Group, and August 24. At its meeting on Thursday, October 18, 2012, the Board of Education once again invited The Engel Burman Group to field questions from to the Board of Education and Elwood community residents. The meeting focused on an interactive discussion of the most recent plans to develop a retirement community on the property currently owned by Oak Tree Dairy. Additionally, several established civic organizations, specifically the Elwood Taxpayers Association, Old Chester Hills Civic Association, and the District's Citizens Finance/Budget Advisory Committee were asked to speak on behalf of their members.

Since receiving your letter, the Elwood School Board spent considerable time discussing the proposed development with representatives of The Engel Burman Group and the Elwood Community. We are now looking to you for assurances and responses to our comments and questions.

Please note that Trustee Andrew L. Kaplan recused himself from any discussion on this topic and the composition of this letter.

The Elwood School Board acknowledges that a down zoning application of this nature has broad issues and considerations that must be addressed in detail, and we expect that town officials will reach out to a number of groups within the Elwood Community for questions and comments. We further acknowledge that the review of all issues pertaining to the proposed development is the responsibility of the Town of Huntington as the only authority to make a final decision on the re-zoning application. However, your decision will have a significant impact on the Elwood School District; therefore, the Elwood Board of Education will address our questions and comments exclusively to issues that are relevant to our schools, its operations, and our concern for the student population.

Please respond to the following comments and questions:

1. The ability to have our students arrive to and from home and school safely and on time is of paramount importance. We do not believe safe and timely transportation will be achieved without additional traffic lights and updated signals surrounding the area between the entrance of our high school / middle school campus and Jericho Turnpike along Elwood Road. Specifically, we believe town officials must insist on a traffic signal at the entrance of the proposed development as well as additional crosswalks and sidewalks if the development is approved.

Additionally, Elwood School District transportation is on a very tight and efficient schedule. We are concerned that the additional traffic/traffic patterns created as a result of this development will require the District to alter its current bus routes or cause the District to contract for more buses at an annual cost of about \$65,000 per bus.

- a. Will the Town conduct an independent traffic study to evaluate the impact of additional traffic on Elwood Road and all connecting roads affected as a result of the increased number of cars and the change in traffic pattern from the new community?
- 2. We need assurances on the increase to the Elwood School District tax base. What is the Town Assessor's forecasted assessed value of the proposed development? What is the projected amount of the Elwood School District's overall assessed value in the near-term and over time? We must be able to accurately inform the Elwood taxpayer of the proposed development's affect on the school tax rate. Additionally, please include any information on STAR, Enhanced Star and tax credits as they relate to the proposed development.
- 3. Can the Elwood School District be guaranteed that school age children under eighteen years of age be restricted from living in the proposed development with its 55+ requirement?
- 4. Will the District be allowed more access to Elwood Park to use for the athletic programs as a result of the path that The Engel Burman Group agreed to build to link the school district property with Elwood Park?

Notwithstanding the fact that the Elwood Board of Education has no legal standing in making a decision on the rezoning of this property, we thank you for the opportunity to share these questions and concerns.
